



Rocker Family Jewish Overnight Camp Scholarship Program

Summer 2026 Guidelines

The Rocker Family Camp Scholarship program helps Greater MetroWest NJ families with the cost of attending Jewish overnight camp. Funds are awarded on a first-come, first-served basis – please apply as early as possible.

Other camps within the [Foundation for Jewish Camp network](#) will be considered based on funding availability.

Eligibility Requirements:

- Camper must be under age 16 as of June 1, 2026
- Camp session must be 12 consecutive days or more
- Family must live in [Greater MetroWest NJ Federation area](#) (Essex, Morris, Sussex, Union and parts of Northern Somerset Counties)
- Adjusted Gross Income (AGI) of \$250,000 or less (or extenuating circumstances to be explained)
- **2024 Tax Form 1040 (top two pages of IRS tax form) MUST be submitted, as well as any Schedules filed**
- Camper must have registered for camp and applied for financial assistance from the camp **prior** to applying for the Rocker Family Scholarship
- Family must also have reached out to extended family and their temple/synagogue (if applicable) for potential funding **prior** to applying for the Rocker Family Scholarship
- Family must contribute a portion of the camp tuition
- **A DETAILED write-up of at least 200 words (approximately 2-3 paragraphs), explaining your family's situation and reasons for applying MUST be provided! Applications will only be considered when complete (including all required tax documents).**

Other Important Information:

- Preference will be given to children for whom Jewish camp is their first intensive Jewish experience and will be attending primary camps noted above
- Up to 3 years of support per child based on annual application
- Maximum of \$5,000 Rocker Family Scholarship support per family per summer
- Scholarships will be paid directly to the camp in the name of the child(ren)
- First time campers may also be eligible for a [One Happy Camper Grant](#)

The scholarship amount awarded will be based on the chart below:

Minimum Income	Maximum Income	Total % of Camp Tuition covered by GMW Federation
\$ -	\$ 75,000	up to 45%
\$ 75,001	\$ 125,000	up to 40%
\$ 125,001	\$ 175,000	up to 35%
\$ 175,001	\$ 225,000	up to 30%
\$ 225,001	\$ 250,000	Up to 25%

Note: Total tuition amount covered by Jewish Federation of Greater MetroWest (GMW) is inclusive of the Rocker Family Scholarship, One Happy Camper (OHC) grant and/or the Russian Speaking Jewish (RSJ) grant.

Volunteer Service Requirement:

Each camper and their family are expected to volunteer for at least two Jewish-related programs (2+ hours each) sponsored by Jewish Federation of Greater MetroWest or other local Jewish organizations by **March 1, 2027**. Federation provides information about meaningful volunteer opportunities and also welcomes the family's suggestions. If you are a clergy member, we ask that you collaborate with us to plan at least one program to directly share Jewish camp information with your congregation/community.

Deadlines:

See below for the four review cycles for summer 2026. **Applications will only be considered when complete (including all required tax documents) and submitted by the due dates below.** Funds are limited and are awarded on a first-come, first-served basis – please apply as early as possible.

Communication of decisions on applications meeting standard criteria will begin approximately four weeks following the deadline and may be longer. Applications with exception requests to the standard criteria may be placed on a waitlist to be considered in future review cycles if funding is available.

The deadlines are as follows:
